RESOLUTION FOR TRANSFER OF REAL PROPERTY

WHEREAS, the Town of Plainfield (“Town”) has no further use for four (4) police patrol units (“Units”), as described on Exhibit A; and

WHEREAS, the Indiana Law Enforcement Academy (“ILEA”), a governmental agency, has a training need for these Units; and


WHEREAS, I.C. 5-22-22, allows for governmental units or agency’s to exchange property with another governmental body or agency upon terms and conditions agreed upon by the governmental bodies or agency’s; and


WHEREAS, “ILEA” has agreed as part of this transfer to provide training credits to the “Town”; specifically, the Plainfield Police Department, as detailed on Exhibit B.


