**RESOLUTION 2021-38**

**RESOLUTION TO DISPOSE OF SURPLUS PROPERTY**

**WHEREAS**, the Town Council (“Council”) of the Town of Plainfield, Indiana has determined that the Hendricks County Communication Center no longer requires the use of the item(s) of personal property on the attached Exhibit A, and such item(s) is surplus property.

**THEREFORE, BE IT RESOLVED**, that the Town Council declares that the item(s) on the attached Exhibit(s) to be surplus property; and

**BE IT FURTHER RESOLVED** that if the cost of disposal, sale and transportation of the item(s) is more than its worth, then the item(s) shall be declared worthless and may be junked or demolished.

**BE IT FURTHER RESOLVED** that, if the item(s) has an individual value of \$1000 or an aggregate value over \$5000, the item(s) shall be sold either via advertised public sale by sealed bids or by auction pursuant to IC 5-22-22-4 or IC 5-22-22-5.

**BE IT FURTHER RESOLVED** that the surplus property may be transferred to another governmental agency or unit pursuant to Indiana statutes.

**NOW THEREFORE BE IT RESOLVED** that the Director and Deputy Director of the Hendricks County Communications Center are hereby authorized to dispose of property identified in Exhibit A in a manner consistent with Indiana law as set forth above.
