RESOLUTION 2021-56

RESOLUTION TO DISPOSE OF SURPLUS PROPERTY

WHEREAS, the Town Council (“Council”) of the Town of Plainfield, Indiana has determined that the Plainfield Police Department no longer needs the items of personal property on the attached in Exhibit A, and such items are surplus property.

THEREFORE, BE IT RESOLVED, that the Town Council declares that the items on the attached Exhibits to be surplus property; and

BE IT FURTHER RESOLVED that if the cost of disposal, sale and transportation of the items is more than they are worth, then the items are declared worthless and may be junked or demolished.

BE IT FURTHER RESOLVED that, if the item has an individual value of \$1000.00 or an aggregate value over \$5000.00, the items shall be sold either in an advertised public sale by sealed bids or by auction pursuant to IC 5-22-22-4 or IC 5-22-22-5.

BE IT FURTHER RESOLVED that the surplus property may be transferred to another governmental agency or unit pursuant to Indiana statutes.

NOW THEREFORE BE IT RESOLVED that the Chief of Police and the Fleet & Facilities Manager of the Town of Plainfield are hereby authorized to dispose of property identified in Exhibit A in a manner consistent with Indiana law as set forth above.
